2024 Nowthen Threshing Show Flea Market Vendor Terms and Conditions

The following terms and conditions define the agreement between you as the Vendor and Nowthen Historical Power Association. Participating in the Flea Market is contingent on agreeing to, as well as adhering to, these terms. All pertinent fire codes, laws, ordinances and regulations pertaining to health, fire prevention and public safety shall be strictly obeyed. All Firearms are Banned on NHPA Property. Failure to follow all of the Terms and Conditions of this Agreement will result in exclusion from participating in future Shows, and/or you will be immediately escorted off of NHPA Property, as deemed necessary by the NHPA Board of Directors, Flea Market Chairperson, or Flea Market Coordinator. RELEASE AND HOLD HARMLESS AGREEMENT: The request to reserve vendors space constitutes an express contractual agreement between you (the vendor) and the Nowthen Historical Power Association, 501c3 Non-Profit Corporation.

Conduct

- No form of harassment, victimization, bullying, discrimination or threatening, malicious or abusive language or conduct will be tolerated towards visitors, customers, vendors, and other members of our organization.
- You will treat everyone with fairness, integrity, dignity and respect.
- You will comply with all Terms & Condition listed herein to participate in our events and during build up and breakdown periods.
- We reserve the right to refuse entry to our events or refuse service, as deemed necessary by NHPA Board of Directors.

<u>Prohibited Items</u> - If a vendor has a prohibited item for sale, the Vendor will be directed to remove the item. Failure to comply will result in expulsion from the flea market and the Vendor will not be invited to future events.

- Alcohol, tobacco, vaping/e-cigarette products.
- CBD products (edible/topical/pet, Delta-8 THC), drug paraphernalia (including but not limited to wood/glass/small pipes, bongs, rolling paper) and hookahs.
- Fireworks, ammunition, weapons and parts of weapons, pocket knives over 3", swords, real, decorative or collectible, etc. No illegal knives, switchblades, throwing stars, brass knuckles, etc. No guns, BB/air guns, pellet guns, pellets. No crossbows, arrows, bows, etc. All toy guns new/used/collectible must have a permanently fastened orange tip which indicates that they are toys. No pepper spray/mace, stun guns, tasers.
- Confederate, offensive, <u>racist/prejudicial</u> literature, flags or items with foul or hateful symbols or language. This includes (but is not limited to) misinformation, disparaging messages, profanity, new and historical WW2 Nazi items, and current political items.

<u>Vehicle Operation / Parking</u> - Vendors may park their vehicles within their reserved site, however during Show Hours it will need to remain parked. Violation of this Policy will result in an immediate escort off of the Show Grounds and not allowed back as a Flea Market Vendor. Vendors are to use either the West Gate Vendor Parking Lot, or the General Admission Parking Lot for access to their vehicles during Show operation hours.

<u>Trash</u> - Please leave your site as you found it. Vendors will be assessed \$50.00 for any clean-up of items left in your site.

<u>YOU BRING IT, DON'T SELL IT, YOU TAKE IT WITH YOU</u> – Any Vendor leaving trash or discarded items on NHPA Property will be assessed a \$50.00 clean-up fee.

Flea Market vendors may sell pre-packaged food items and are required to follow safe food handling guidelines procedures and product labeling as described in Minnesota regulations.

All Flea Market Vendors are required to carry their own insurance.

It is understood and I agreed that by signing this agreement I fully and finally release and hold harmless the 2024 Nowthen Threshing Show / Nowthen Historical Power Association from any and all liability for all claims of every nature and kind whatsoever, including death, personal injury, loss, theft, or damages to personal property, whether or not caused by the Nowthen Threshing Show, Flea Market or NHPA's negligence.

PENALTY — Operators who do not have Form ST19 or a similar written document from sellers can be fined a penalty of \$100 for each seller that is not in compliance for each day of the selling event.

Information for Sellers and Event Operators

Operators/organizers of craft, antique, coin, stamp or comic book shows; flea markets; convention exhibit areas; or similar events are required by Minnesota law to get written evidence that persons who do business at the show or event have a valid Minnesota tax ID number.

If a seller is not required to have a Minnesota tax ID number, the seller must give the operator a written statement that items offered for sale are not subject to sales tax.

All operators (including operators of community sponsored events and nonprofit organizations) must obtain written evidence from sellers.

Certain individual sellers are not required to register to collect sales tax if they qualify for the isolated and occasional sales exemption. To qualify, all the following conditions must be met:

- The seller participates in only one event per calendar year that lasts no more than three days:
- The seller makes sales of \$500 or less during the calendar year; and
- The seller provides a written statement to that effect, and includes the seller's name, address and telephone number.

This isolated and occasional sales provision applies to individuals only. It does not apply to businesses.

<u>REQUESTED HOURS OF OPERATION</u> - Indoor Vendors:

8:00 AM to 6:00 PM – Friday and Saturday 9:00 AM to 4:00 PM – Sunday

Outdoor Vendors: 8:00 AM to 6:00 PM – Friday and Saturday - (With the option to extend hours to scheduled show times) 9:00 AM to 4:00 PM - Sunday

<u>VENDOR SET-UP</u> – Wednesday Aug. 14th and Thursday Aug. 15th. Hours – 10:00 AM to 7:00 PM

> Please Enter at the Exhibitor Entrance (AKA: West Gate) for Set-up Entrance Vendor Set-up / Tear Down is Prohibited During Show Hours

<u>PARKING</u> – Vendors may park their vehicles within their reserved site, however during Show Hours it will need to remain parked. Violation of this Policy will result in an immediate escort off of the Show Grounds and not allowed back as a Flea Market Vendor. Vendors are to use the either the West Gate Vendor Parking Lot, or the General Admission Parking Lot for access to their vehicles during Show operation hours.

MN SALES TAX ID # - Completed MN Operator Certificate of Compliance (ST-19) Forms are required.

<u>CUSTOMER PICK-UP</u> – For items sold that require vehicle pick up, please give your customer a written receipt so they may enter at the West Gate for access. An escort is required for all vehicle traffic during Show hours. Please contact me for vehicle escort.

<u>CAMPGROUND</u> - Primitive Campsites are available beginning Thursday Aug. 15th.

QUIET TIME - Between 10:00 pm and 7:00 am. PLEASE do not use generators during this time.

<u>MEDICAL EMERGENCY - CALL 911</u> - The <u>Street Address for the Show Grounds</u>: 7415 Old Viking Blvd; Nowthen MN. A Medical Team is also on-site during show hours.


